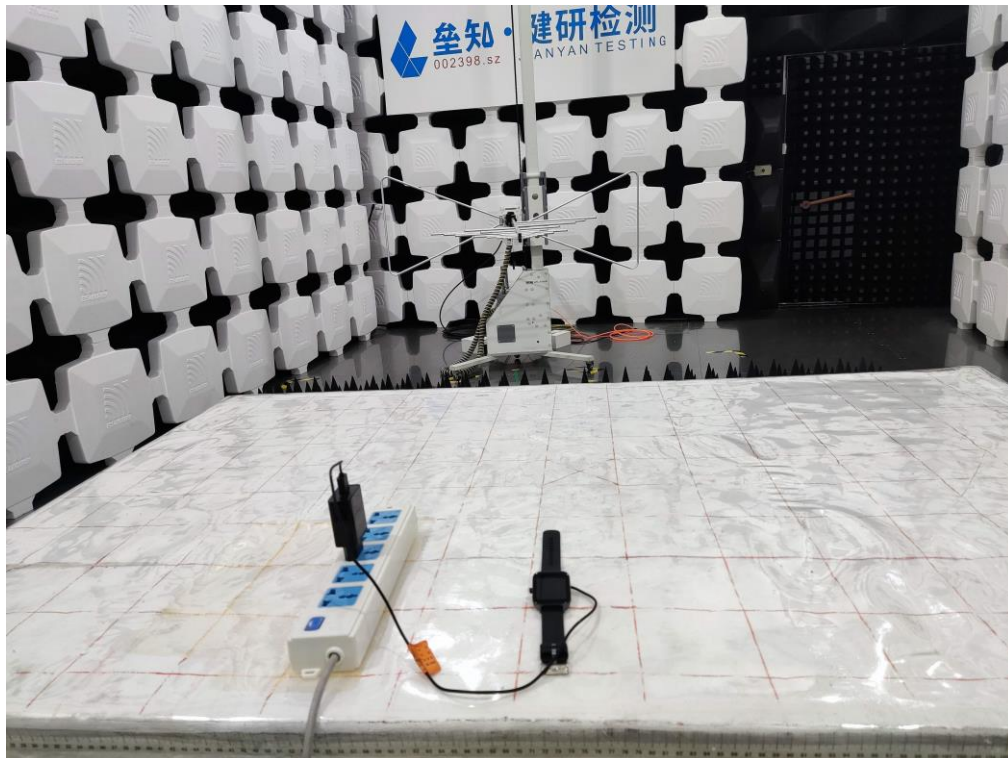

Radiated Emission Above 1GHz





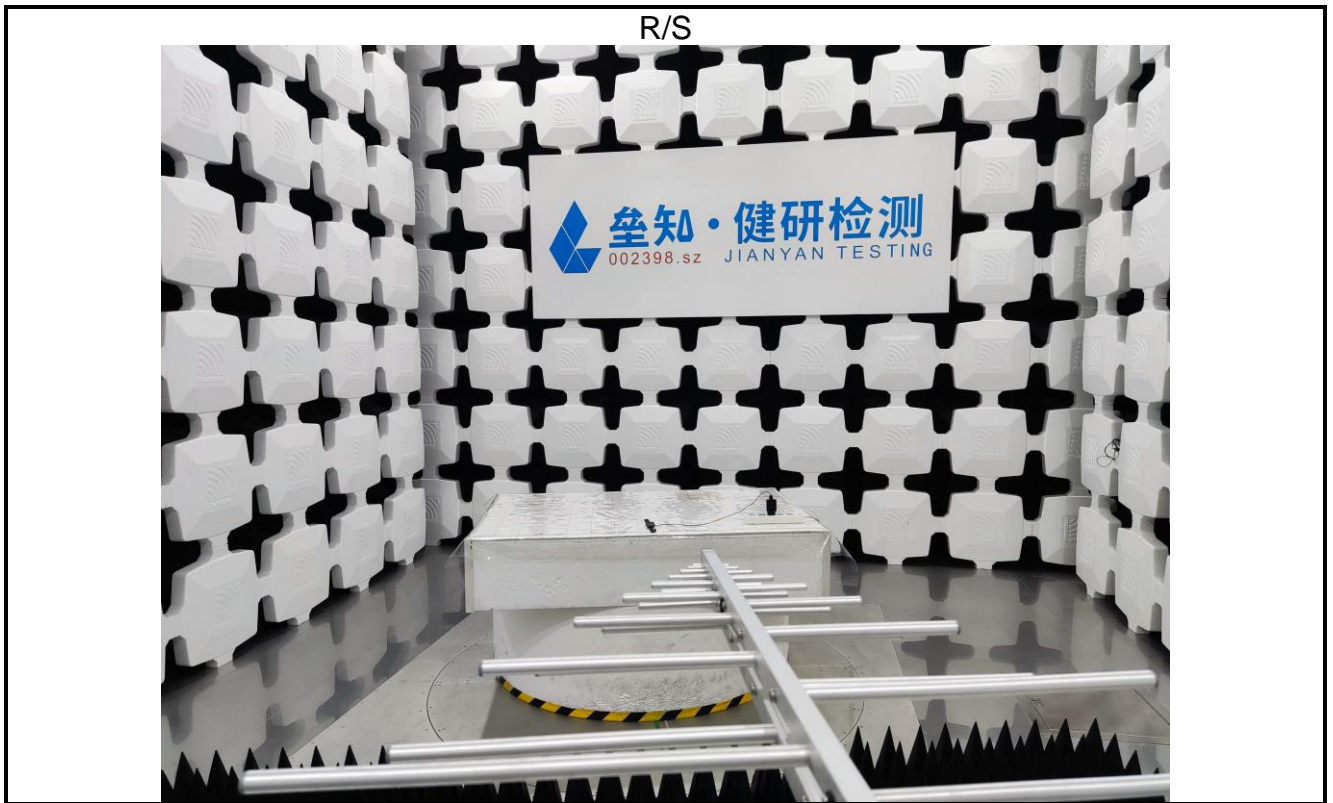
