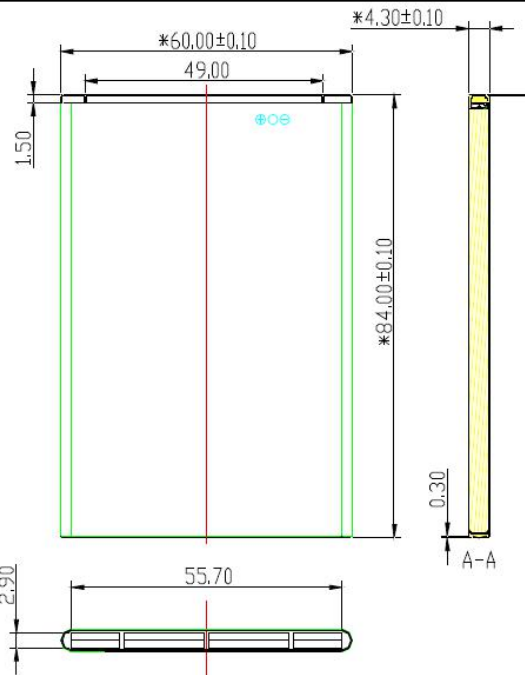

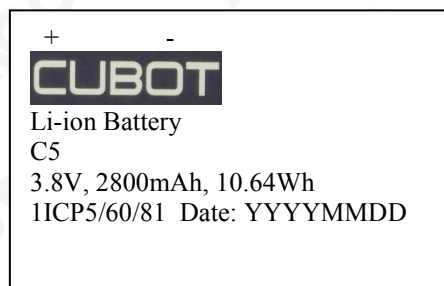
Battery (Unit:mm)

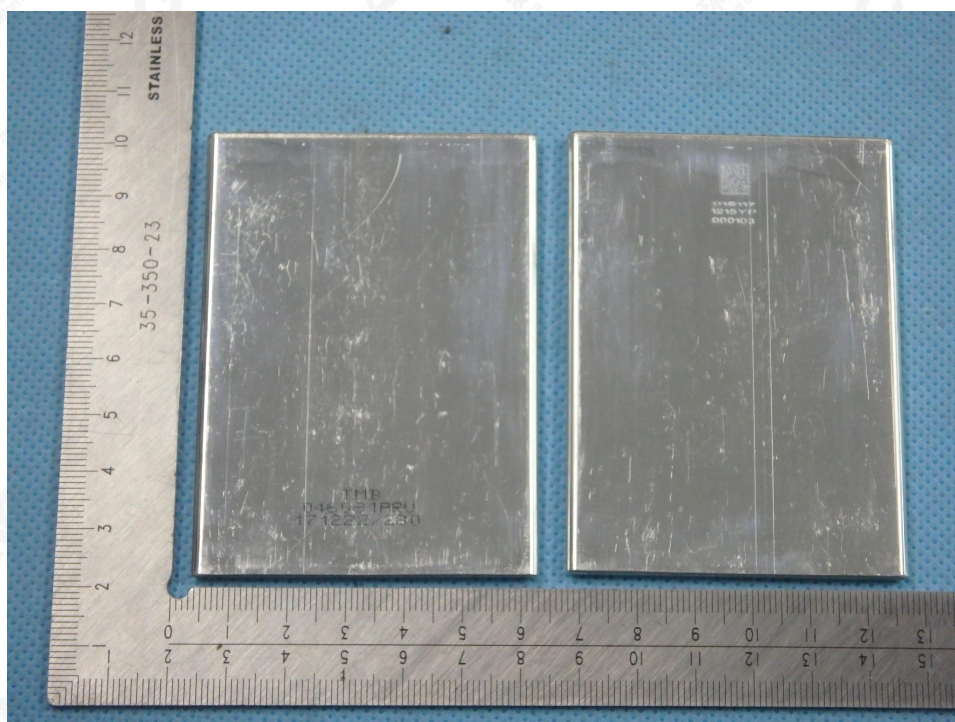


Fig. 2 – View of cell

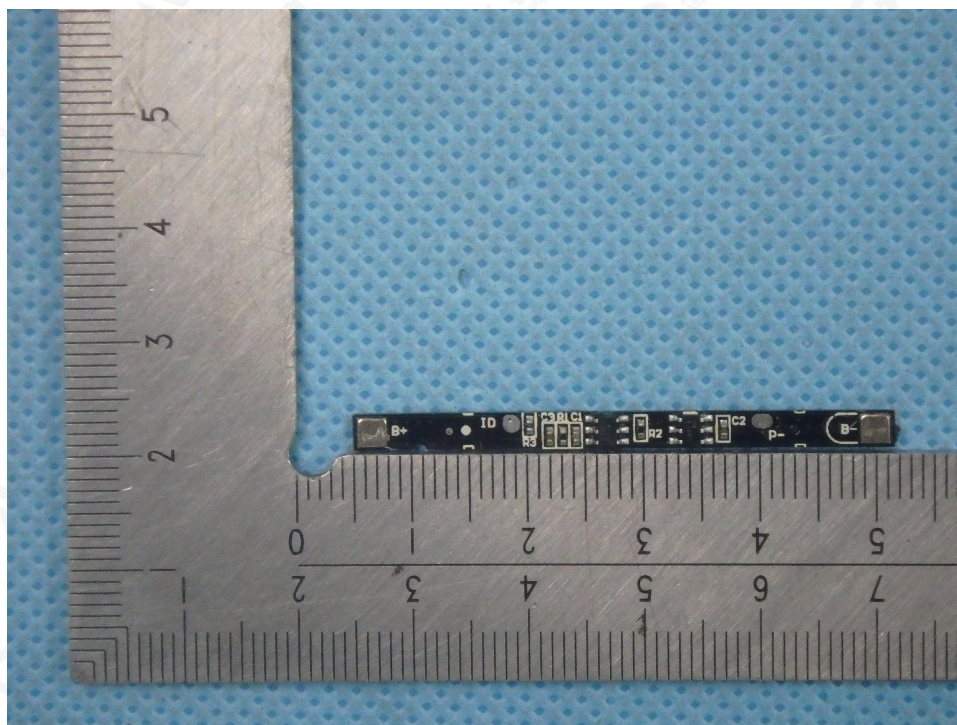


Fig. 3 — View of PCB

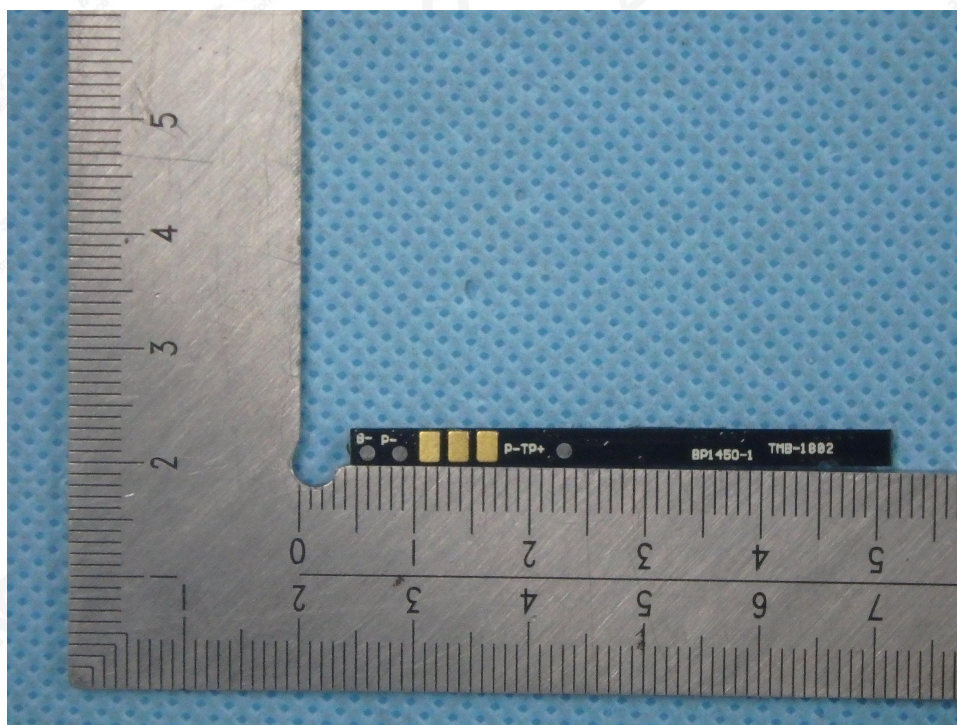


Fig. 4 — View of PCB
