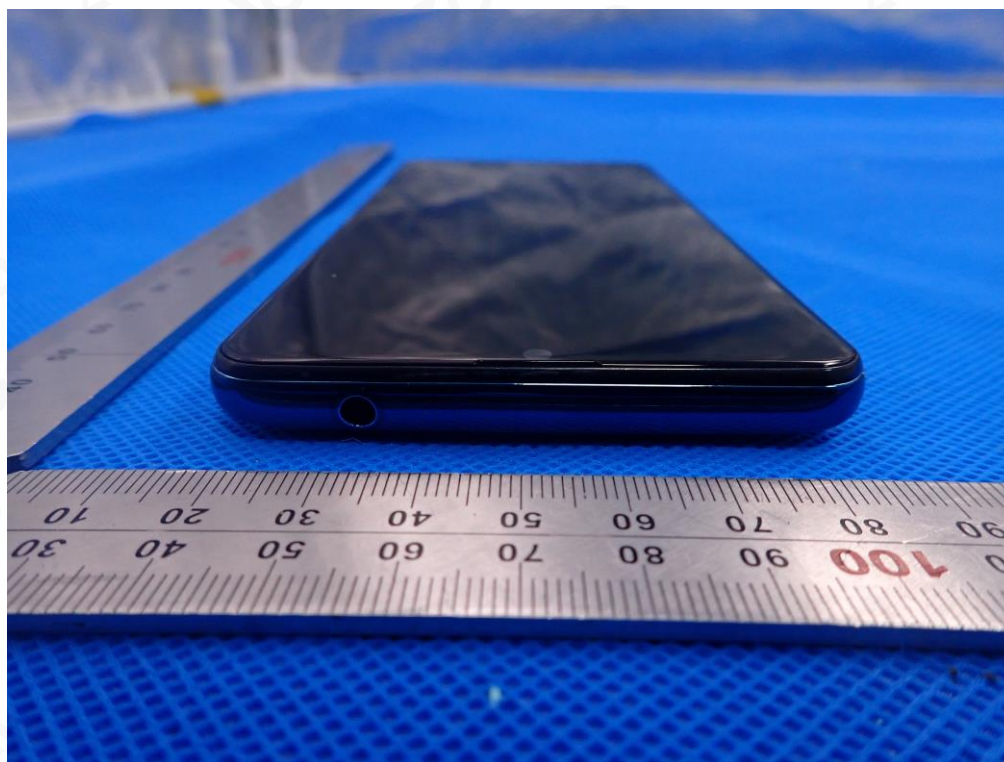

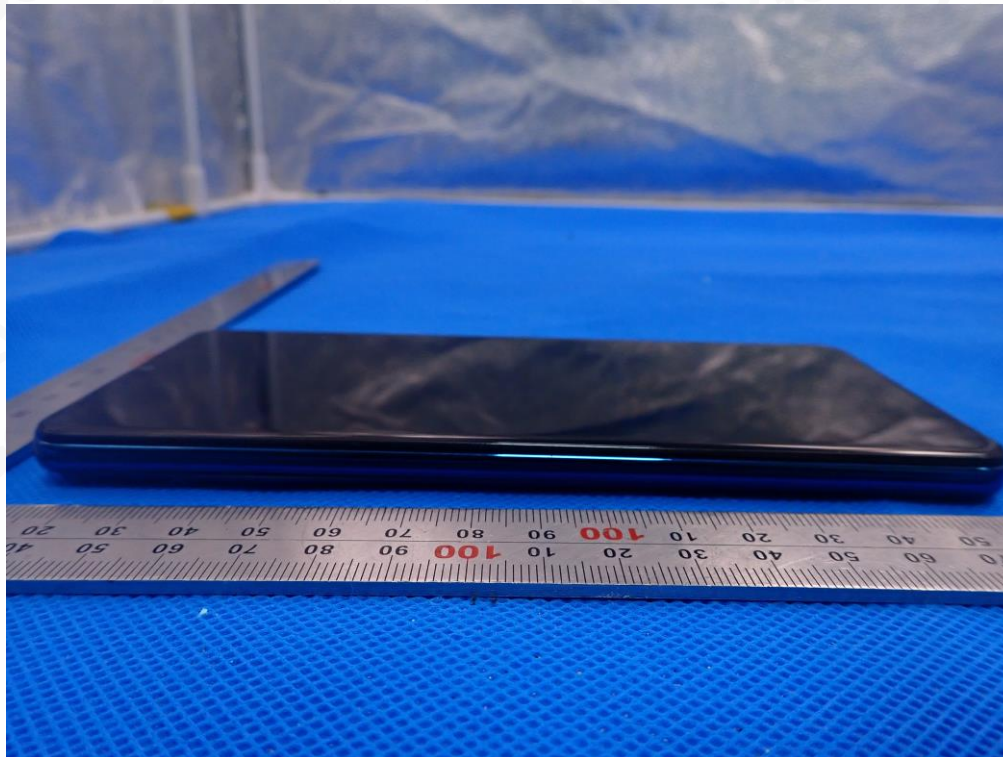

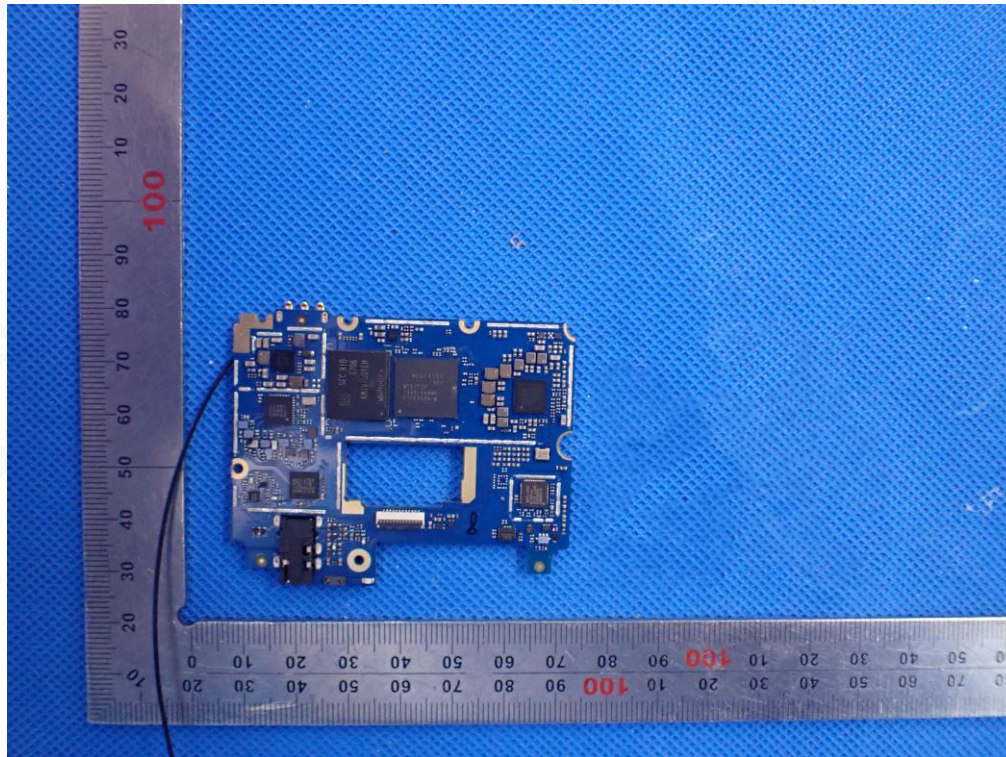




OPEN VIEW OF EUT(FIGURE 2)

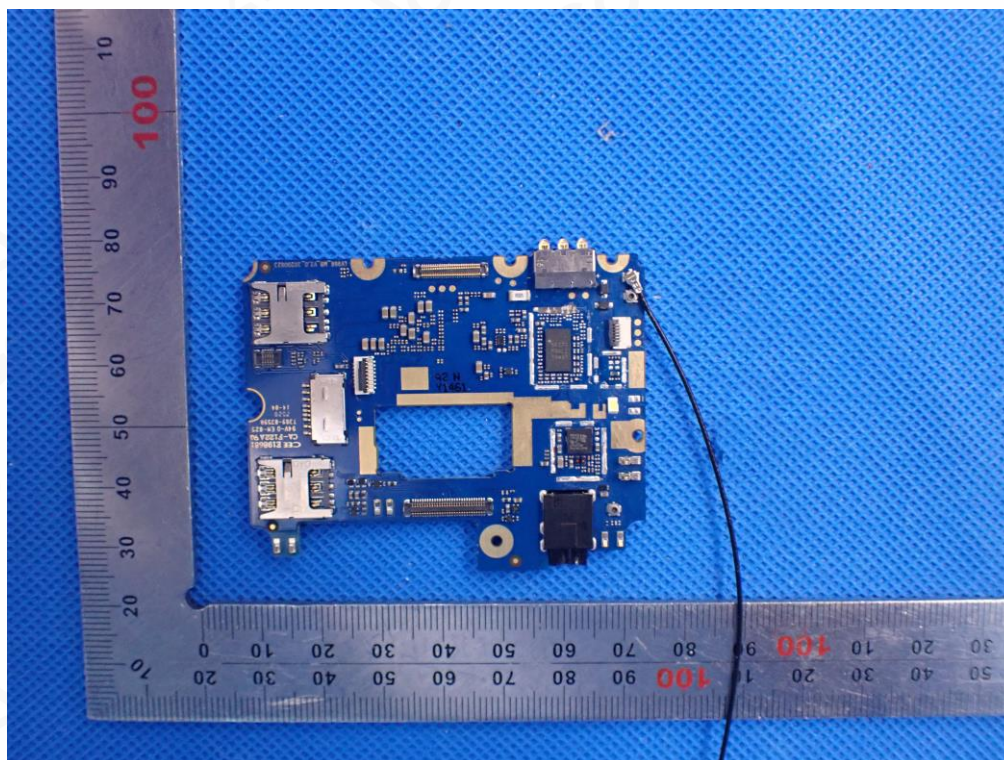

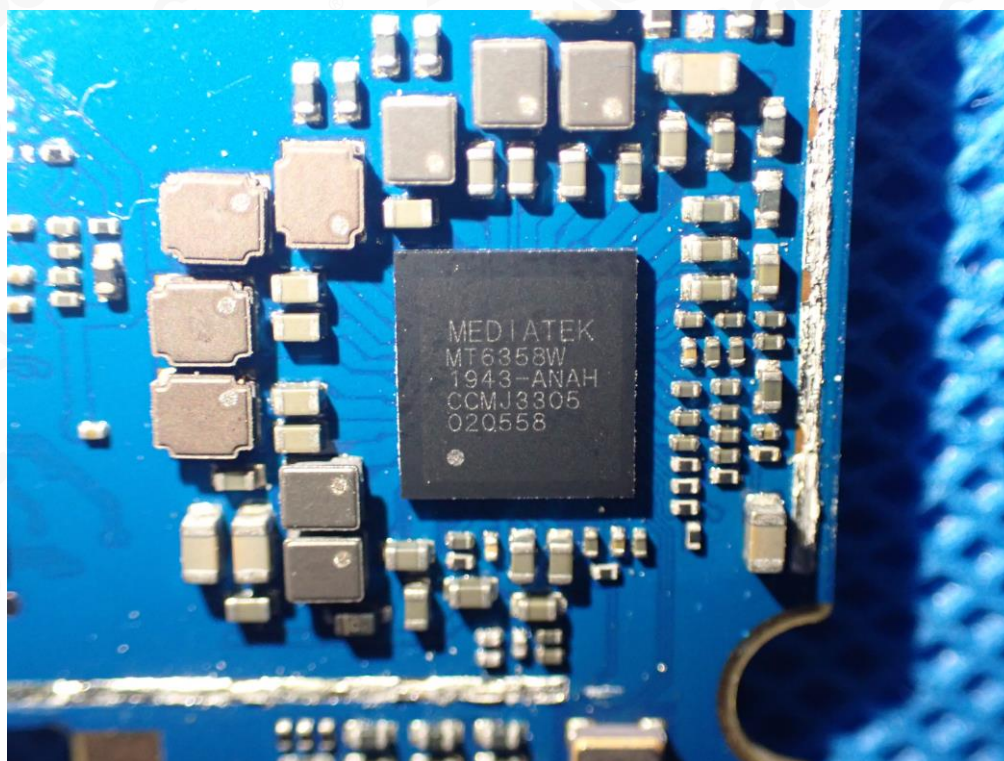




INTERNAL VIEW OF EUT(FIGURE 2)

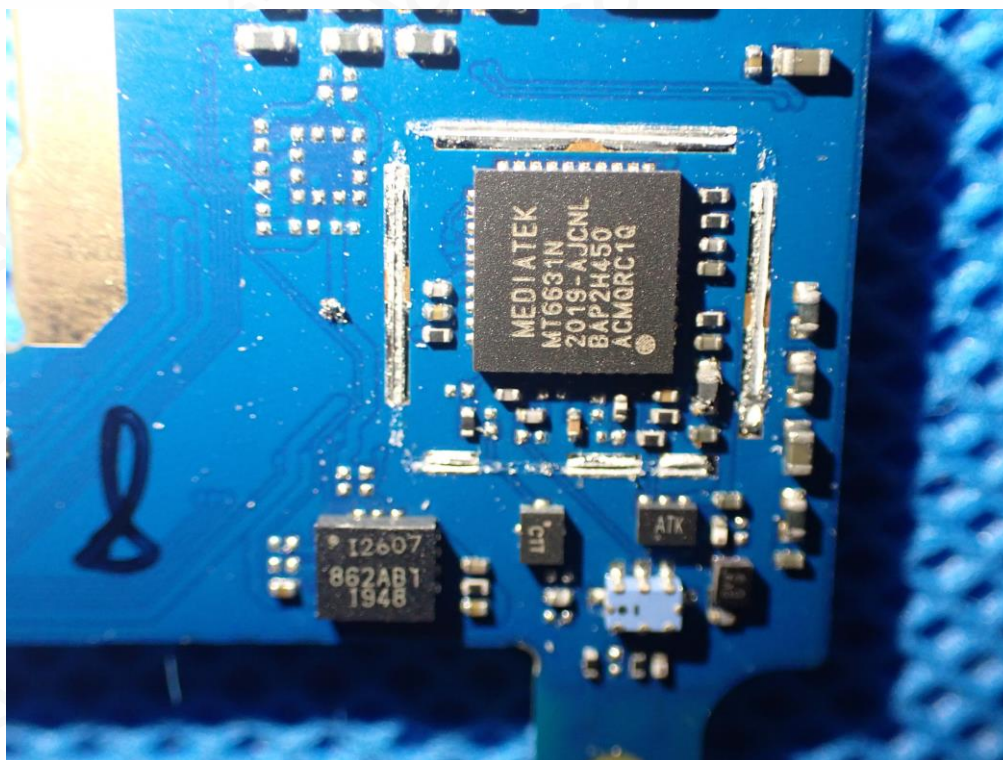

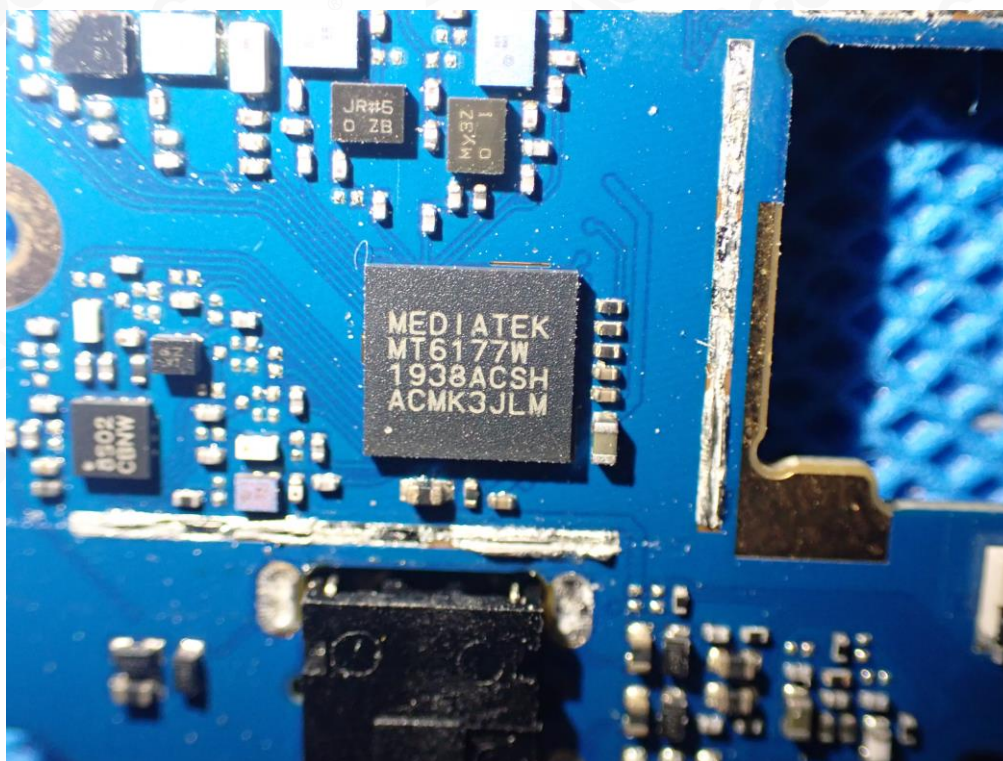




INTERNAL VIEW OF EUT(FIGURE 3)

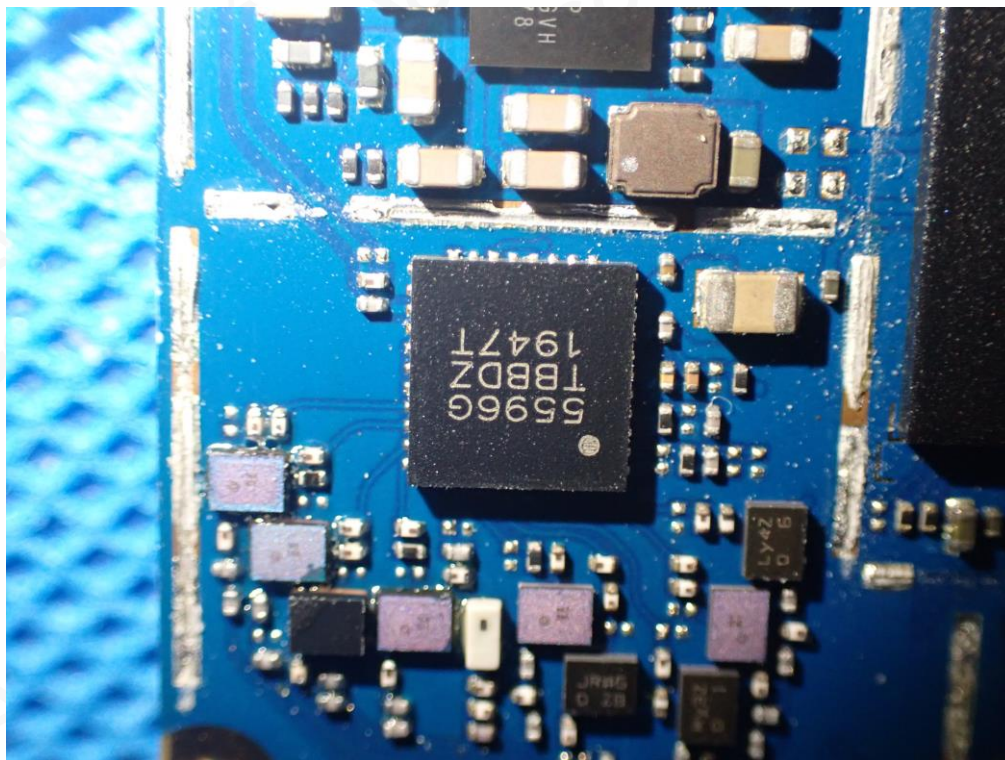

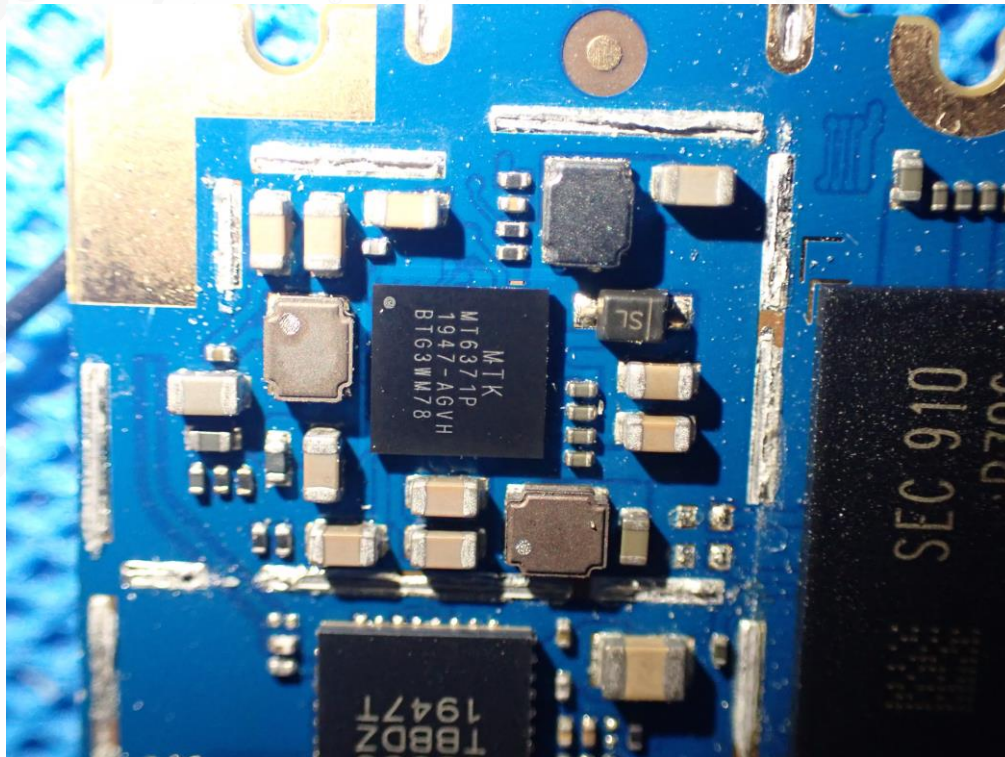




INTERNAL VIEW OF EUT(FIGURE 5)

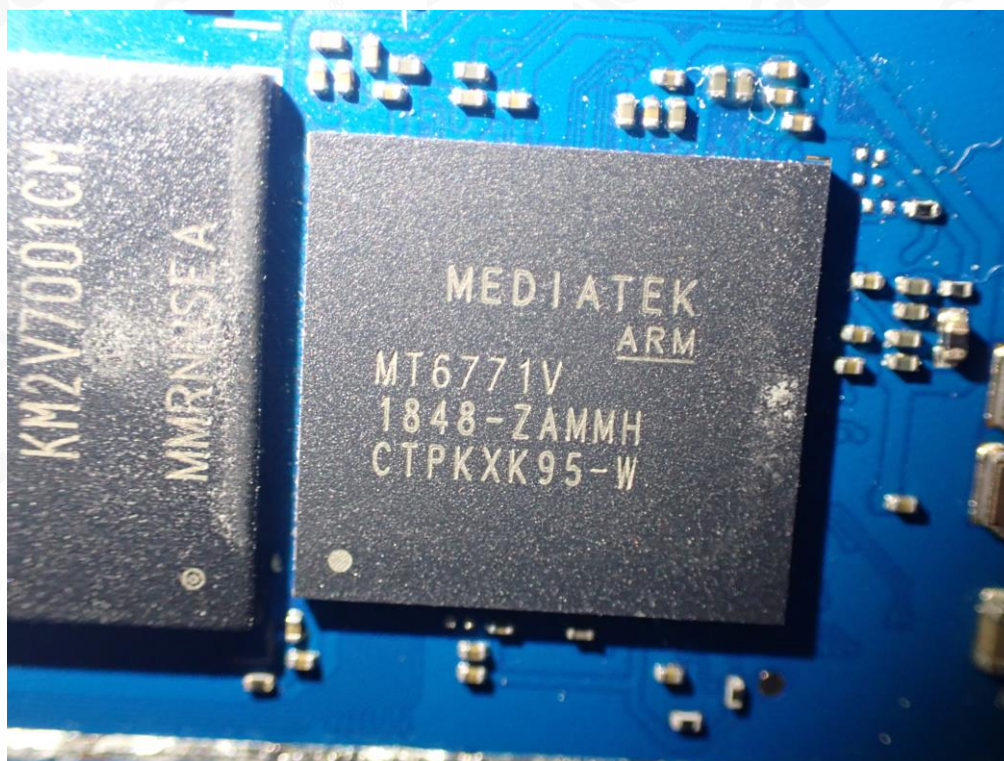

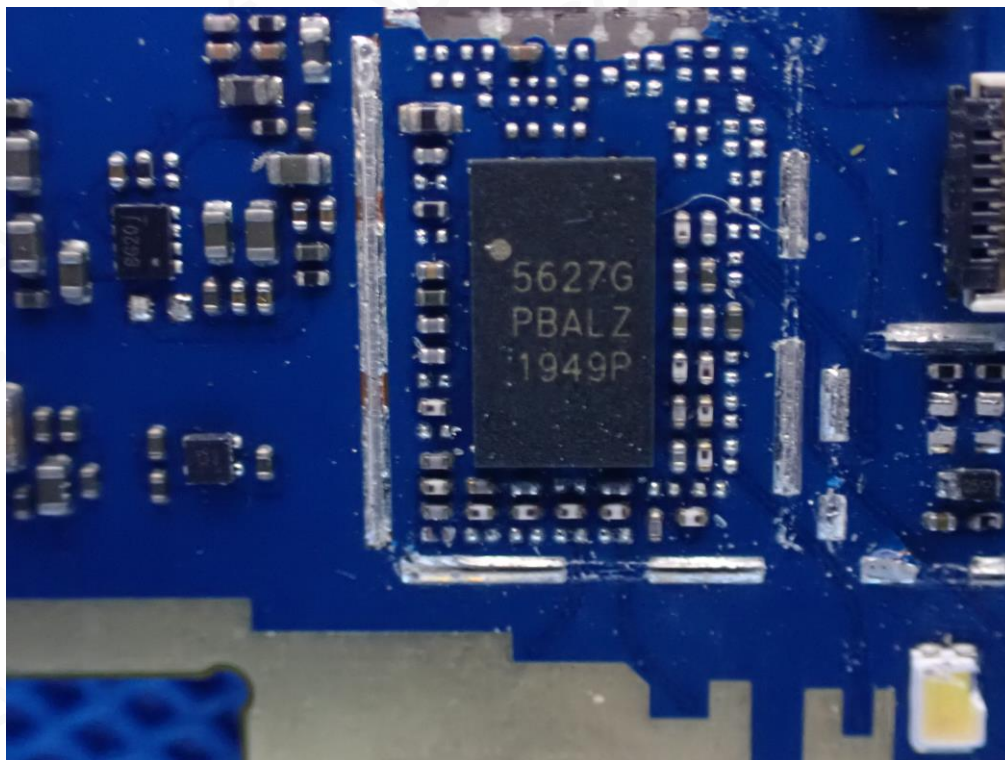

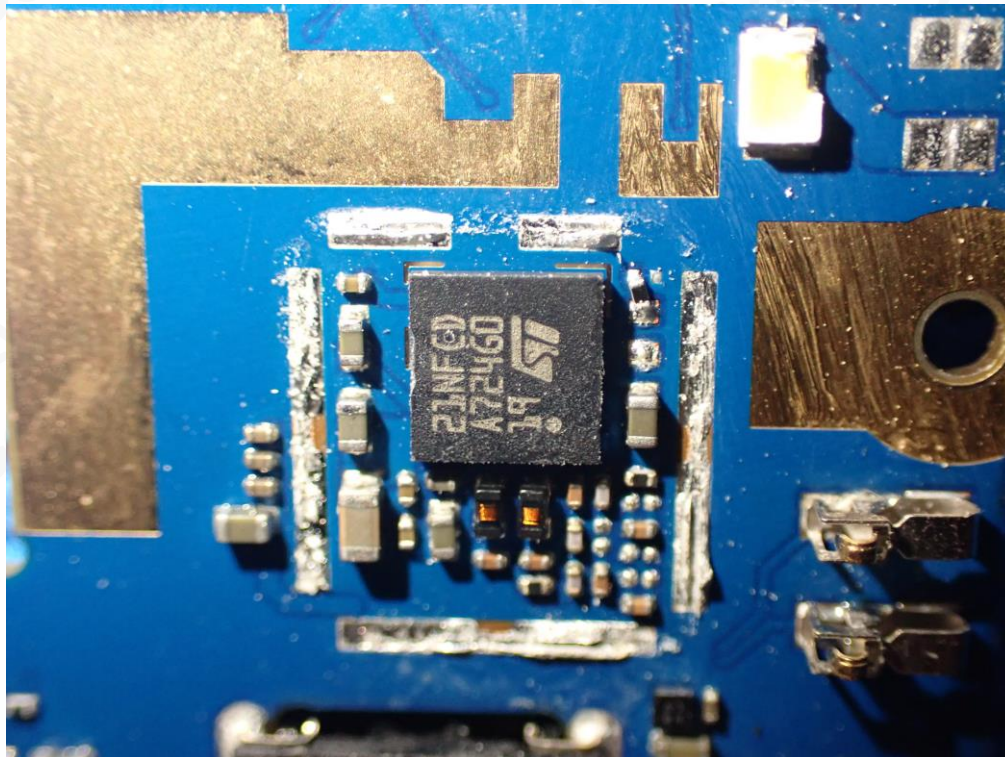




INTERNAL VIEW OF EUT(FIGURE 9)

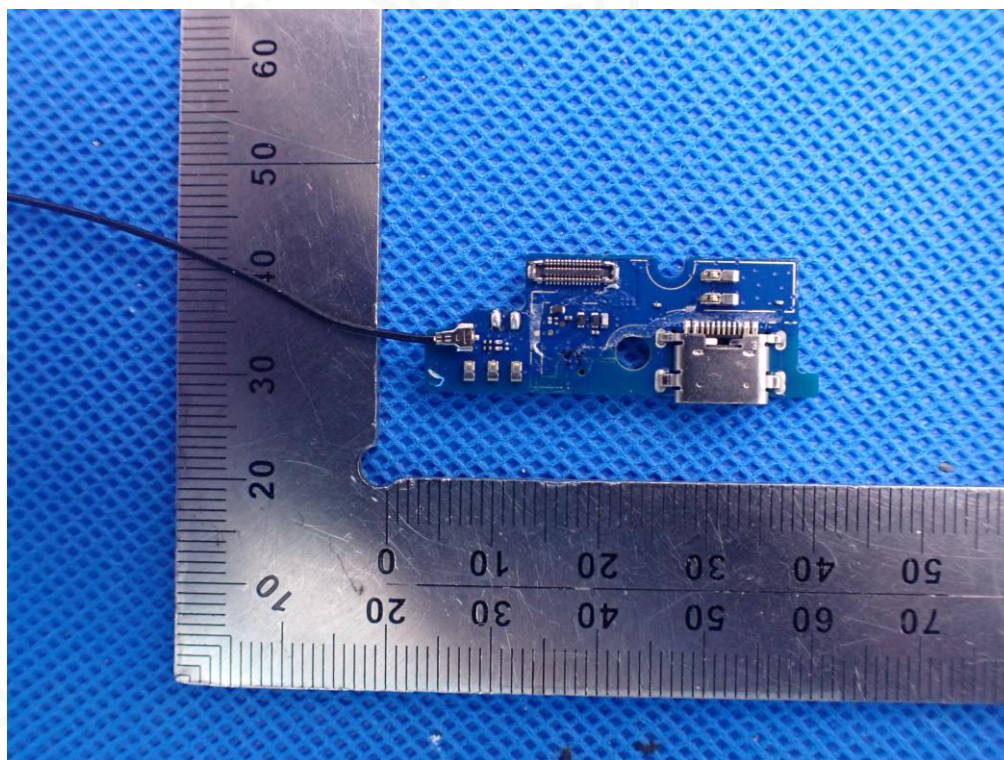

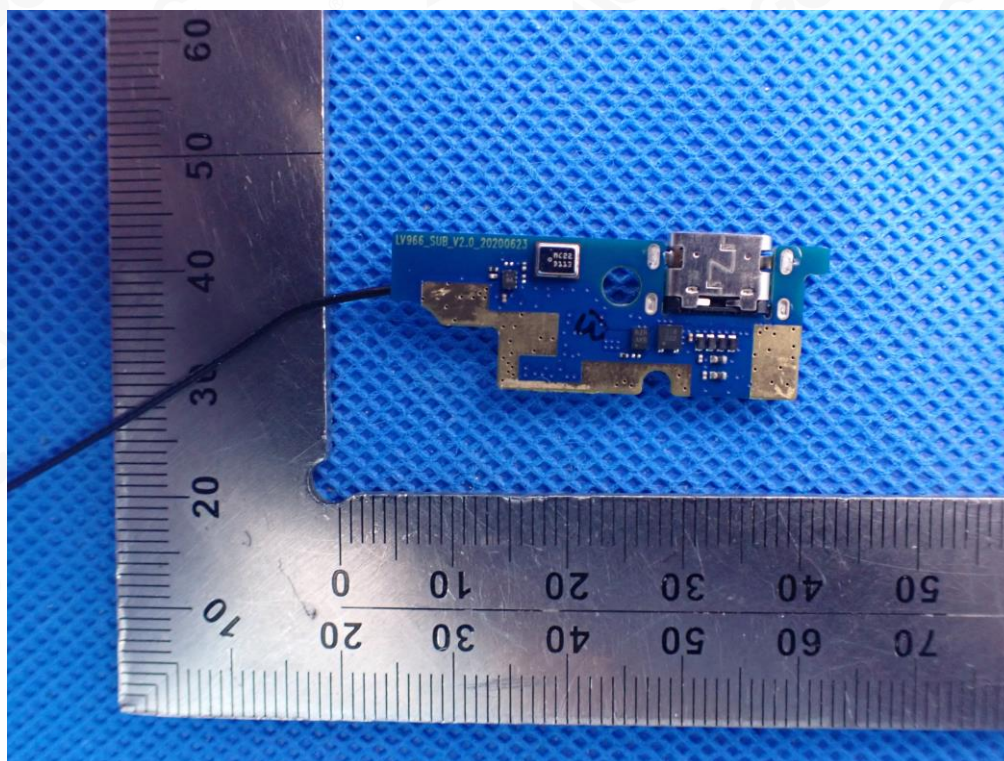




INTERNAL VIEW OF EUT(FIGURE 11)
