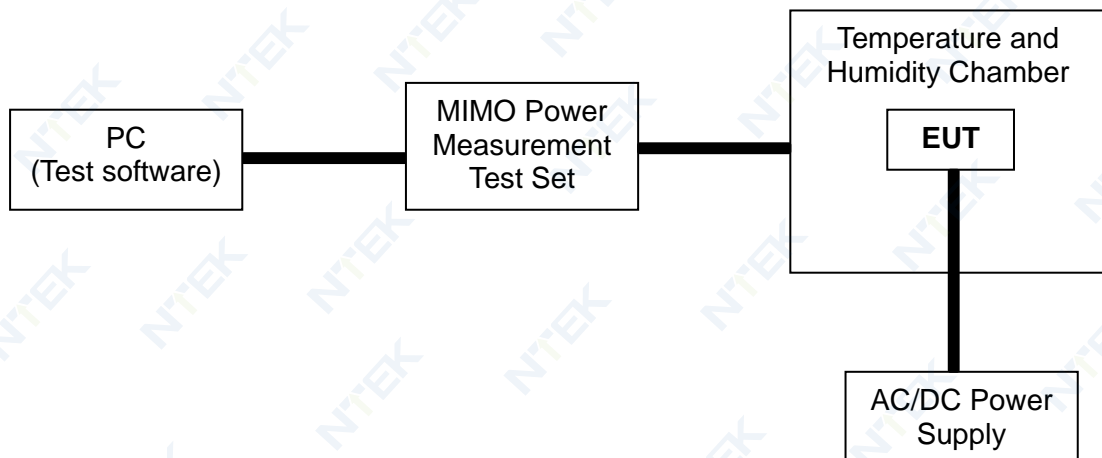

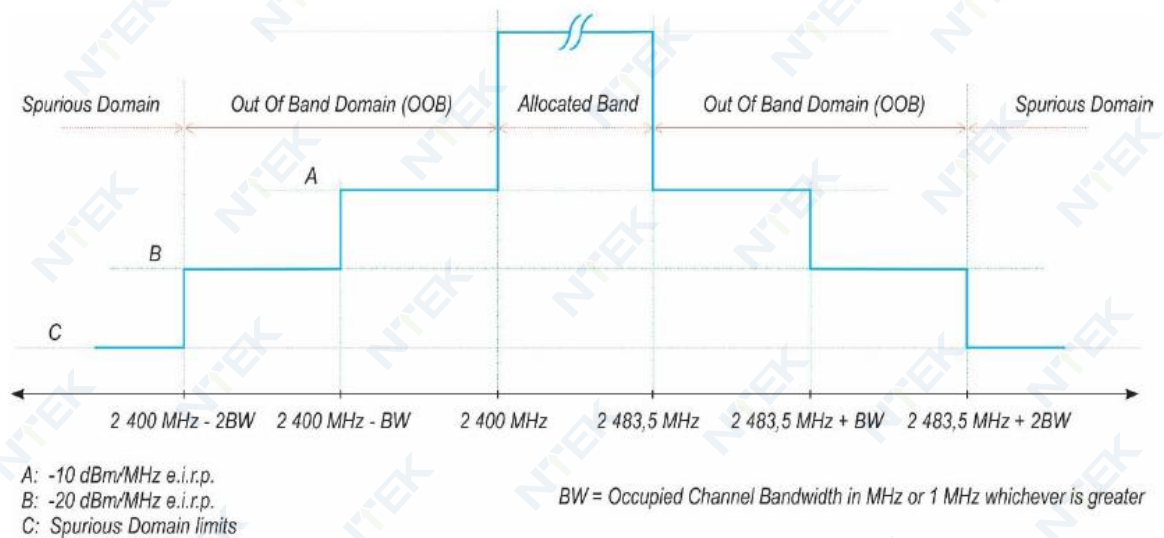


Figure 1: Transmit mask

10. RECEIVER BLOCKING

10.1 PERFORMANCE CRITERIA

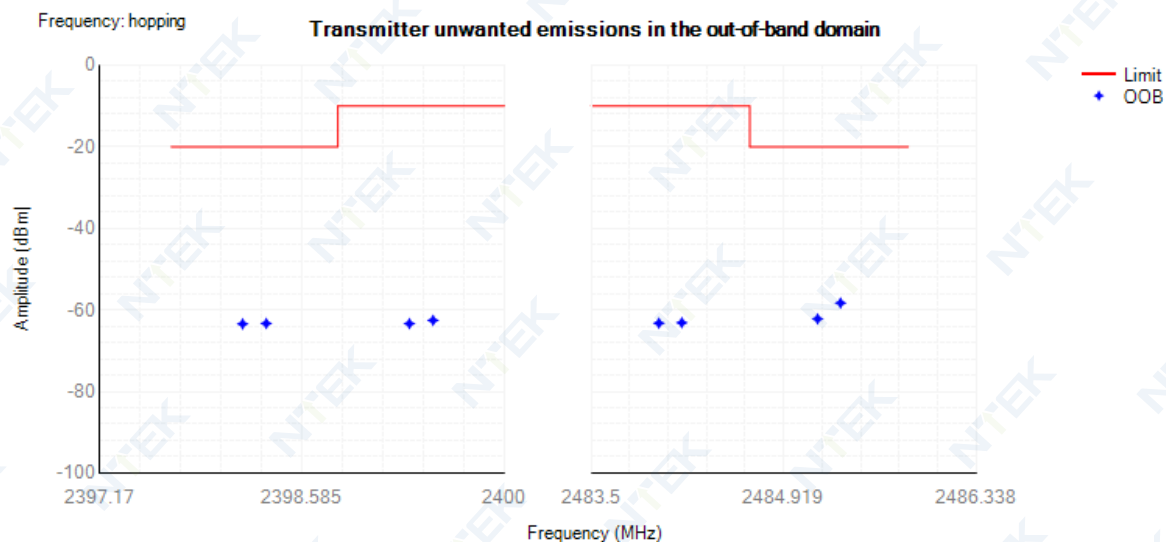
Tx. Emissions OOB NVNT 1-DH5 2480MHz



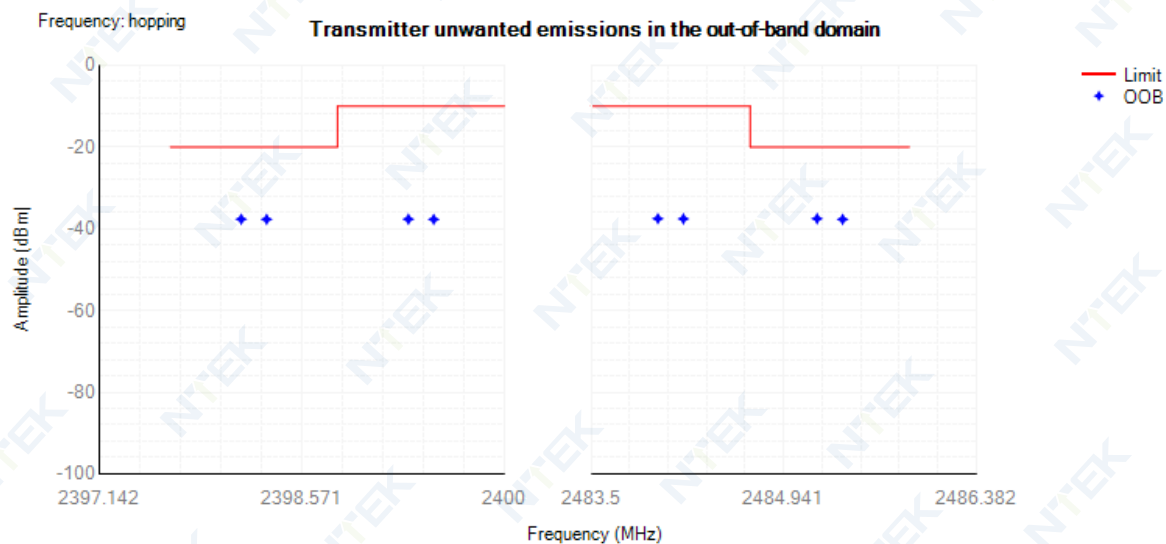

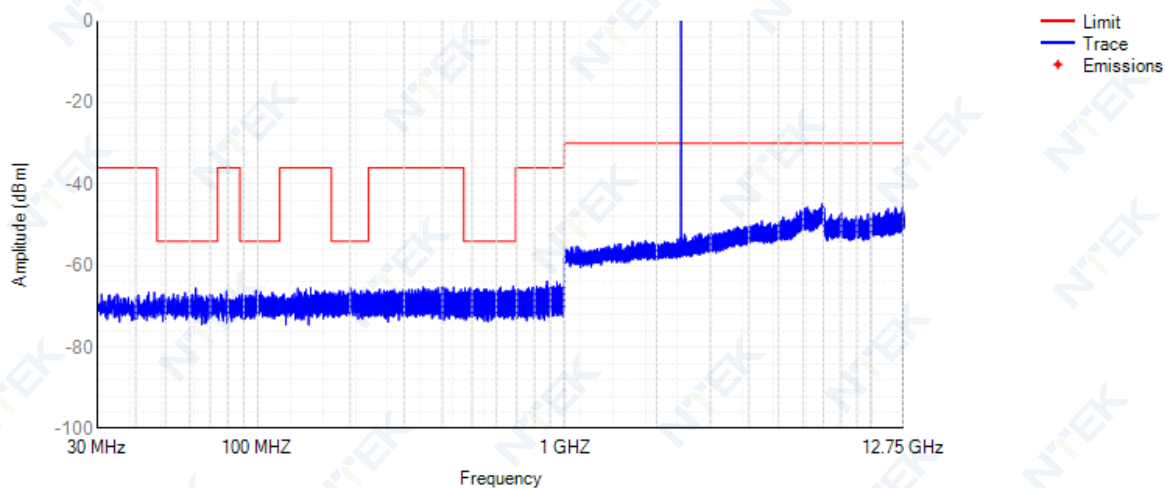

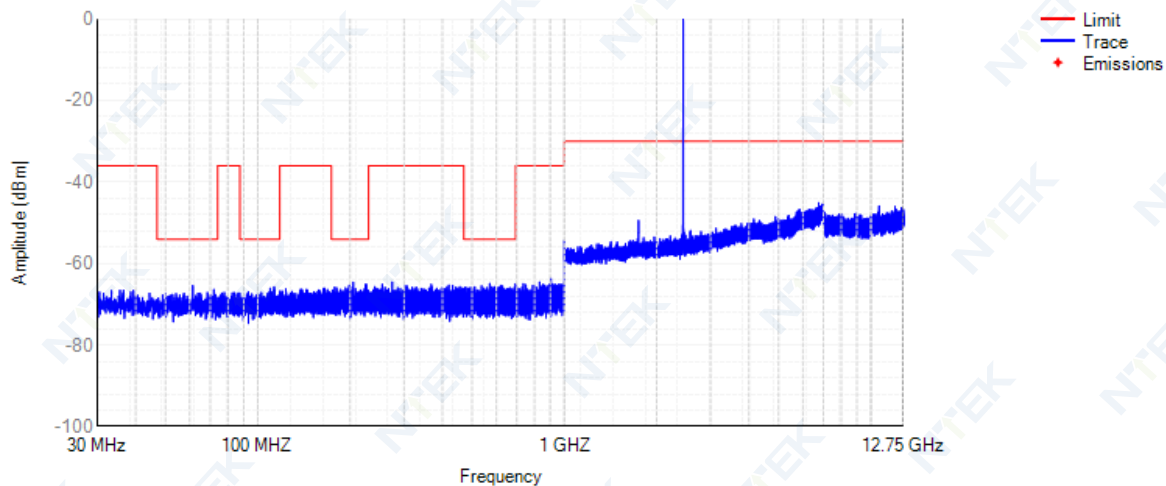

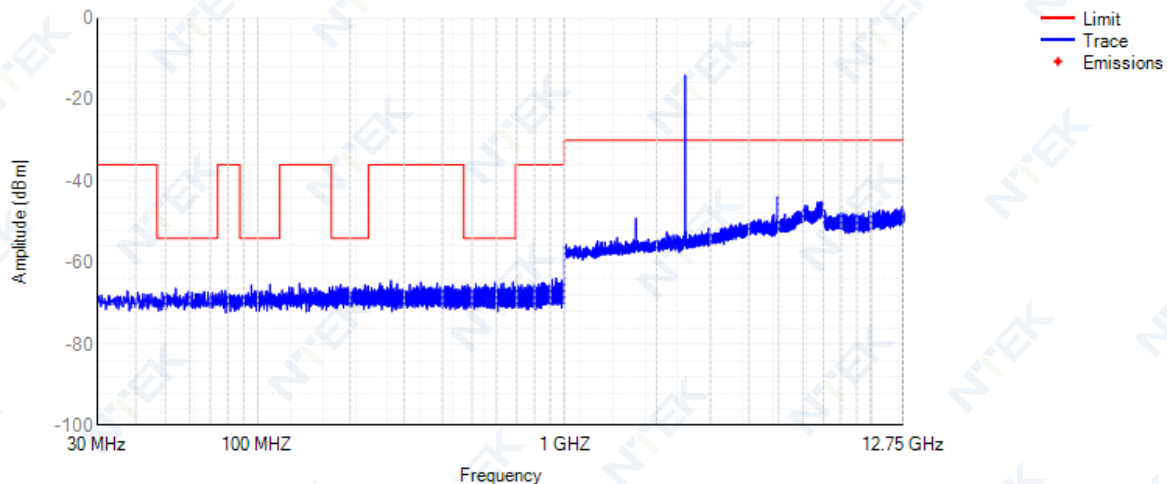

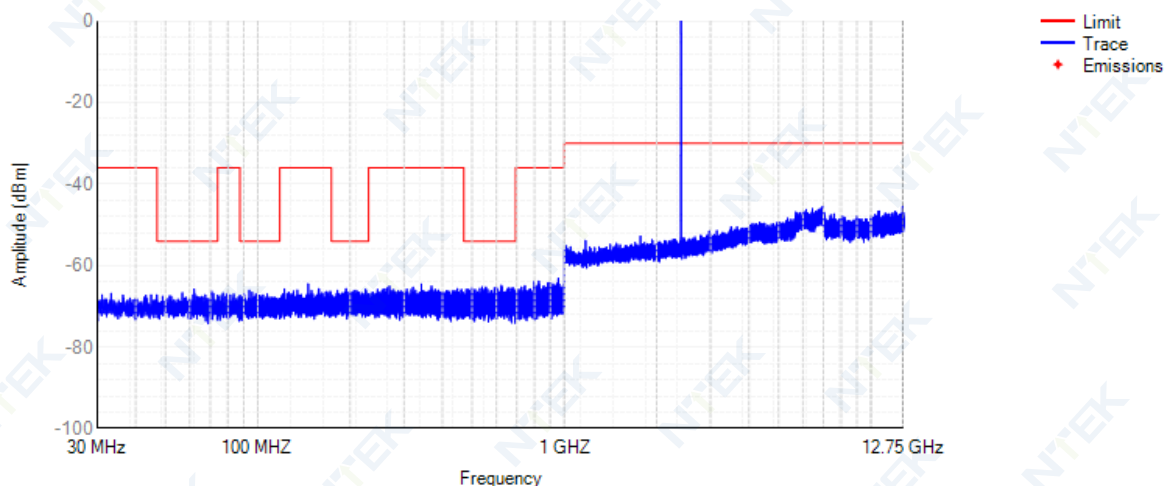

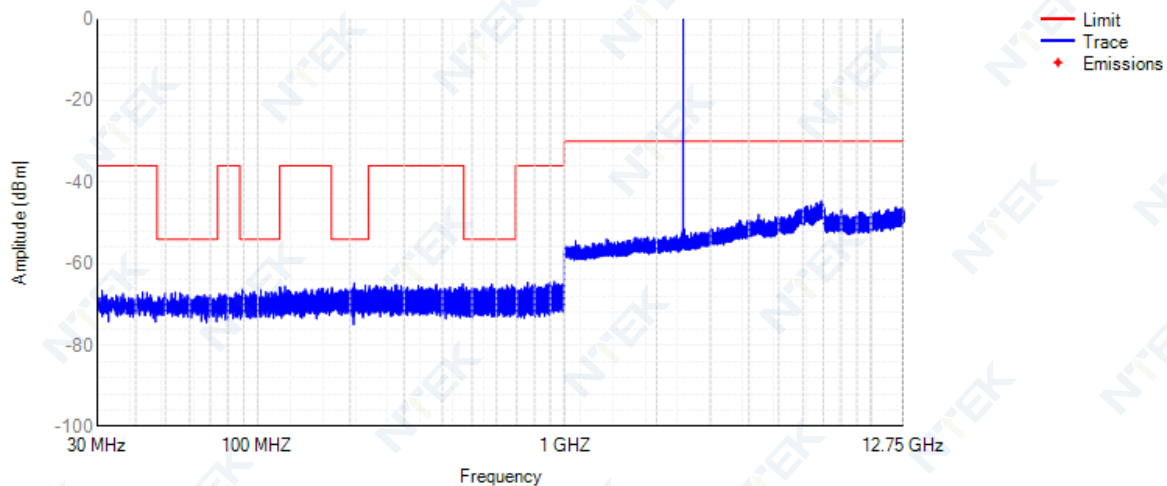
